

RESOLUTION R-2013-092

Amending Resolution R-2005-012 and Resolution R-2013-086 Provisions for Council Agenda Items

WHEREAS, the Mayor and City Council approved Resolution No.: R-2005-012 on March 30, 2005, a copy of which is attached hereto and incorporated herein by reference; and,

WHEREAS, Resolution No.: R-2005-012 provided that the City Council agendas shall include all matters submitted for consideration by the City Manager, City Attorney, City boards, commissions and committees, or a member of the Council; and,

WHEREAS, Resolution No.: R-2005-012 provided that no matter submitted by a third party shall be included on the Council's meeting agenda unless such matter has the sponsorship of a member of the Council or the City Manager, in which case the name of the sponsor shall be stated on the agenda and that persons seeking to address the Council concerning matters not on the agenda may do so at the conclusion of Council action upon its meeting agenda, except at meetings restricted to consideration of the specific agenda for that meeting; and,

WHEREAS, the Mayor and City Council approved Resolution No.: R-2013-086 on September 3, 2013, amending R-2005-012 to require that any supporting materials necessary for review of items placed on the regularly scheduled meeting agenda for action be provided to City Councilmembers and to the public no later than seventy-two (72) hours prior to the City Council meeting, a copy of which is attached hereto and incorporated herein by reference; and,

WHEREAS, it is the desire of Council to further amend Resolution R-2005-012 and R-2013-086 to require that any supporting materials necessary for review of items placed on the regularly scheduled meeting agenda for action be provided to City Councilmembers and to the public no later than seventy-two (72) hours prior to the City Council regular meeting, and further requires that any material such as ordinance(s), contract(s) and/or resolution(s) to be acted on by city council as part of a special called meeting agenda be provided to City Councilmembers and to the public no later than twenty-four (24) hours prior to the special called City Council meeting. This does not prohibit auxiliary materials from being submitted after the twenty-four (24) hour requirement for a special called City Council meeting; NOW, THEREFORE,

BE IT RESOLVED by the Mayor and City Council this 1st day of October, 2013 that Resolution No.: R-2005-012 and Resolution No.: R-2013-086, a copy of each being attached hereto and incorporated herein by reference, are hereby amended to require that any supporting materials necessary for review of items placed on the regularly scheduled meeting agenda for action be provided to City Councilmembers and to the public no later than seventy-two (72) hours prior to the City Council regular meeting, and further require that any material such as ordinance(s), contract(s) and/or resolution(s) to be acted on by city council as part of a special called meeting agenda be provided to City Councilmembers and to the public no later than twenty-four (24) hours prior to the special called City Council meeting. This does not prohibit auxiliary materials from being submitted after the twenty-four (24) hour requirement for a special called City Council meeting.




