Annexing Golden Acres

WHEREAS, a proper petition has been filed with the City Council by seventy-five (75%) per cent of the property owners of the within described properties under the provisions of South Carolina Code Ann. Section 5-3-150; and,

WHEREAS, it appears to City Council that the annexation of the properties would be in the best interest of the property owners and the City of Columbia; NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Columbia, South Carolina, this 25th day of October, 2000, that the properties described herein are hereby annexed to and become part of the City of Columbia effective December 31, 2000. These properties shall be zoned RG-1, C-2 and C-3.


