WHEREAS, 2010-002 Annexing 2428 McKinley Street, Richland County TMS #11504-30-26; 2010-003 Annexing 2409 High Street, Richland County TMS #11605-14-05; 2010-005 Annexing 1800 Gary Street, Richland County TMS #11612-02-03; 2010-008 Annexing SW/S Gary Street, 5551 Farrow Road and R2607 Varn Street, Richland County TMS #11612-02-02, 11612-02-05 and 11612-05-02; 2010-009 Annexing two parcels on Bethune Court, Richland County TMS #11606-05-17 and 11606-05-18; 2010-011 Annexing 2400 High Street, Richland County TMS #11605-13-01; 2010-013 Annexing 2432 Chappelle Street, Richland County TMS #11605-15-05; 2010-014 Annexing 2403 High Street, Richland County TMS #11605-14-06; 2010-016 Annexing 42 Bethune Court, Richland County TMS #11606-05-10; 2010-017 Annexing 3033 Farrow Road and 3035 Farrow Road, Richland County TMS #11503-05-03, 11503-05-04 and 11503-05-05; and 2010-018 Annexing 27 Bethune Court, Richland County TMS #11606-05-13 were given first reading approval by City Council on January 20, 2010 and second reading approval on February 3, 2010, with an effective date of annexation into the City as of April 30, 2010; and,

WHEREAS, the properties annexed by these ordinances are zoned and used for residential purposes; and,

WHEREAS, a vacancy occurred in City Council District 2 on March 9, 2010, which term ends on June 30, 2012; and,

WHEREAS, the United States District Court three judge panel enjoined the election scheduled for April 6, 2010 to fill the vacancy in the District 2 Council seat unless Section 5 preclearance was received prior to the election; and,

WHEREAS, Section 5 preclearance was not received prior to the polls opening on April 6, 2010 at 7:00 o'clock a.m.; and,

WHEREAS, by Resolution R-2010-038 enacted on April 7, 2010, City Council set a special election for the vacant City Council District 2 seat to be held on July 9, 2010; and,

WHEREAS, these properties have not been given preclearance by the United States Justice Department Voting Rights Division to participate in the July 9, 2010 special election as required by L

Section 5 of the Voting Rights Act; and,

WHEREAS, there is not sufficient time before the special election date of July 9, 2010 to allow for submission and request for a preclearance for these properties to participate in the special election; NOW, THEREFORE,


