Permitting the Fire Department to collect money for the Muscular Dystrophy Association

WHEREAS, the Fire Department requests permission pursuant to South Carolina Code Ann. §5-27-910 for their personnel to collect money to benefit the Muscular Dystrophy Association at the intersections of Assembly Street and Gervais Street; Huger Street and Blossom Street; Devine Street and Harden Street; Bull Street and Elmwood Avenue; Farrow Road and Beltline Boulevard; Main Street and Sunset Boulevard; Bush River Road and Broad River Road; South Beltline Boulevard and Rosewood Drive and Leesburg Road and Garners Ferry Road, on Wednesday, March 24, 2011; Thursday, March 25, 2011 and Friday, March 26, 2011; NOW, THEREFORE,

BE IT RESOLVED by the Mayor and City Council of the City of Columbia, South Carolina this 1st day of March, 2011, that Fire Department personnel are permitted to collect money for the Muscular Dystrophy Association at the intersections of Assembly Street and Gervais Street; Huger Street and Blossom Street; Devine Street and Harden Street; Bull Street and Elmwood Avenue; Farrow Road and Beltline Boulevard; Main Street and Sunset Boulevard; Bush River Road and Broad River Road; South Beltline Boulevard and Rosewood Drive and Leesburg Road and Garners Ferry Road, provided, however, that: (1) there is no interference with either vehicular or pedestrian traffic; (2) no personnel shall leave the curb or raised median while soliciting for or collecting funds; and (3) personnel shall remove all trash from the sidewalk and median.


