BE IT RESOLVED by the Mayor and City Council of the City of Columbia, South Carolina, this 24th day of May, 2011, that pursuant to the 1998 Code of Ordinances of the City of Columbia, South Carolina, Chapter 11, Licenses, Permits and Miscellaneous Business Regulations, Article VII, Peddlers and Solicitors, Division 3, Sidewalk Vending, the following are authorized designated locations for street vendors:



- LIST A Hot dogs, sausages, hamburgers, tacos, burritos, baked potatoes, prepackaged sandwiches, and anything in a layered arrangement like a sandwich (i.e., Gyros, wraps, etc.), chips, hot and cold (non-alcoholic) beverages, peanuts, salads, vegetables, other packaged meals, and other related items specifically approved for this location which meet the provisions of the franchise ordinance.
- LIST B Bagels, chips, biscuits, popcorn, nuts, pretzels, hot and cold (non-alcoholic) beverages and other related items specifically approved for this location which meet the provisions of the franchise ordinance.
- LIST C Pastries, candy, ice products, ice cream, milk products, frozen yogurt, hot and cold (non-alcoholic) beverages and other related items specifically approved for this location which meet the provisions of the franchise ordinance.
- LIST D Flowers and other related items specifically approved for this location which meet the provisions of the franchise ordinance.
