

RESOLUTION NO.: R-2004-006

Authorizing Annual Sidewalk Sale for
Merchants in the 2100-3200 blocks of Devine Street

WHEREAS, the merchants in the 2100-3200 blocks of Devine Street (the Merchants) are sponsoring their Annual Sidewalk Sale for merchants in the 2100-3200 blocks of Devine Street on Saturday, January 31, 2004; and,

WHEREAS, the Merchants have requested permission to conduct sidewalk sales as part of the celebration; and,

WHEREAS, it has been determined that such an event would be in the public interest;
NOW, THEREFORE,

BE IT RESOLVED by the Mayor and Council this 21st day of January, 2004, that between the hours of 9:00 a.m. and 6:00 p.m. on Saturday, January 31, 2004, merchants in the 2100-3200 blocks of Devine Street are authorized to operate sale booths for items normally sold in their course of business as well as food and beverages items, except alcoholic beverages, beer and wine, on the sidewalks immediately in front of their places of business; and,

BE IT FURTHER RESOLVED that all vendors be restricted to stationary location; and,

BE IT FURTHER RESOLVED that only pedestrian traffic will be allowed within the area. All other traffic, including, but not limited to, automobiles, trucks, motorcycles, mopeds, bicycles, skate boards, and horses, except police horses, is prohibited. All pets shall be prohibited. Coolers, glass bottles and breakable glasses and/or cups shall be prohibited; and,

PROVIDED, HOWEVER, that sidewalks shall not be obstructed for pedestrian traffic in violation of Sec. 14-32, 1998 Code of Ordinances of the City of Columbia, South Carolina. and


that no vendor locations be allowed on any street during the period of the celebration.
